Articles presenting case reports (of failures as well as successes), treatment planning sessions, innovations in methods or products, and clinical and technical applications of esthetic dentistry are invited. In addition, guest editorials may be solicited periodically by the editorial board.

Submission Instructions

Submission of manuscripts in order of preference:

- 1. Via online submission (www.manuscriptmanager.com/ijed).** Manuscript texts should be uploaded as a PC Word (doc) file with tables and figures* included at the end of the document. No paper version required. Online submissions are automatically uploaded into the reviewer assignment schedule and are therefore processed immediately.
- 2. Via e-mail (richter@quintessenz.de) as a PC Word document.** Illustrations* can be attached in any format that can be opened using Adobe Photoshop (eg, tif, jpg, psd, eps), or as Microsoft PowerPoint documents (ppt). No paper version required.
- 3. Via courier/regular mail (see address below).** One paper copy of the manuscript plus a floppy disk or CD-ROM (mandatory) containing a PC Word file of the manuscript text, tables, and figures* in any format that can be opened using Adobe Photoshop (eg, tif, jpg, psd, eps).

***Illustrations that cannot be sent electronically** (eg, original slides or high-quality prints) should be sent to the mailing address above. They will be scanned and sent to reviewers via e-mail along with the manuscript to expedite the evaluation process.

Resubmitted manuscripts should also be submitted in the above manner. Please note that supplying electronic versions of your tables and illustrations upon resubmission will expedite publication if the manuscript is accepted.

Review/editing of manuscripts. Manuscripts will be reviewed by the editors and at least two reviewers with expertise within the scope of the article. The publisher reserves the right to edit accepted manuscripts to fit the space available and to ensure conciseness, clarity, and stylistic consistency, subject to the author's final approval.

Adherence to guidelines. Manuscripts that are not prepared in accordance with these guidelines will be returned to the author before review.

Manuscript Preparation

- Manuscript format.** Text should be typed double-spaced with 1-inch margins all around. All pages should be numbered. The first page should include the title of the article (descriptive but as concise as possible) and the names, degrees, title, professional affiliation, and full address of all authors. Phone, fax, and e-mail address must also be provided for the corresponding author, who will be assumed to be the first-listed author unless otherwise noted.
- Abstract.** A 150- to 250-word abstract must be included.
- Abbreviations.** The full term for which an abbreviation stands should precede its first use in the text unless it is a standard unit of measurement.
- Trade names.** Generic terms are to be used whenever possible, but when trade names are used, the name of the manufacturer should be provided parenthetically at first mention.
- Legends.** Figure legends should be typed (double-spaced) as a group on a separate page and included in the manuscript file.
- Tables.** Each table should be logically organized, typed as a separate page in the manuscript, and numbered consecutively. The title and footnotes should be typed on the same page as the table.
- References.** References should be typed on a separate page and included in the manuscript. Cite all references numerically, in order of appearance in the text. Limit references to those specifically cited in

the text. Provide complete information for each reference, including names of all authors (up to six). Avoid using abstracts as references. Do not include unpublished data or personal communications in the reference list; cite such references parenthetically in the text and include a date. Use the following style for the reference list:

Illustrations

Digital Format. When submitting digital or scanned images please consider the following points:

- Good print quality requires images with a minimum resolution of 300 dpi at an appropriate image output size (at least 3 inches wide).
- To help us reproduce natural color, we encourage you to work with an 18% gray photo background. For more information about capturing and managing digital images, contact the editor via e-mail at devigus@dentist.ch.

Nondigital Format. When submitting nondigital images please consider the following points:

- Clinical photographs/radiographs. Submit original 35-mm slides, high-quality glossy prints, or original film.
- Line drawings. Figures, charts, and graphs should be professionally drawn. Text should be large enough to be read after reduction. Good quality computer-generated laser prints are acceptable (no photocopies). Lines within graphs should be of a single weight unless special emphasis is needed.
- The figure number, first author's last name, and proper orientation should be indicated on each image.
- Handle illustration materials carefully. Do not bend, fold, or use paper clips. Do not mount slides in glass.
- For protection against damage or loss, authors should retain duplicate slides and illustrations.
- All illustrations are returned after publication.

Mandatory Submission and Copyright Form

The Mandatory Submission and Copyright Form, signed by all authors, must be sent to the editorial office before the manuscript review process can begin. Permission and Waivers

- **Permission of author and publisher** must be obtained for the direct use of material (text, photos, drawings) under copyright that does not belong to the author. Legends and tables should contain proper credit lines (full citation of the source and the words "Reprinted with permission").

- **Submit all letters of permission and waivers with the manuscript.**
